Summary: Three Region 2000 organizations believe it is time to leave behind the "Region 2000" brand and adopt an identity more closely associated with "Central Virginia". As these changes are fundamental to each organization, the localities that make up their membership must approve of the change to the organizational documents. Here are the proposed name changes.

- 1. FROM: Virginia's Region 2000 Partnership Regional Council: Local Government Council. TO: Central Virginia Planning District Commission.
- 2. FROM: Region 2000 Workforce Development Council and the Region 2000 Workforce Development Board. TO: Central Virginia Workforce Development Council and Central Virginia Workforce Development Board.
- 3. FROM: Region 2000 Radio Communications Board. TO: Central Virginia Radio Communications Board.

Other than the name changes, there are no other substantive changes being proposed to the organizational documents.

**Recommended Motion:** I move that the Board approve the adoption of new names, as proposed, for these three organizations.

Dear Dean:

The Virginia's Region 2000 Local Government is proud to serve Amherst County as the Planning District Commission for this region since 1969. Over that time the organization has had various names to reflect organizational changes and evolving missions. We began as the Central Virginia Planning District Commission, grew to become the Region 2000 Regional Commission and now are called the Virginia's Region 2000 Partnership Regional Council: Local Government Council.

We believe that we are at a point now that it is time to evolve a name change once more.

With the merger of the Region 2000 Economic Development Council and the Lynchburg Regional Chamber of Commerce into the Lynchburg Regional Business Alliance, we no longer have the Partnership organization that utilized the Region 2000 brand. Although the "Region 2000" brand is now recognized by state officials as a geographic identifier for the Counties/City/Towns in this area, it is also identified as the economic development marketing agency for the region. Although we support the work of the Regional Alliance in their economic development marketing, that's not what we do. But as long as we carry the Region 2000 brand, there's a possibility of confusion about our role and mission among our localities and our stakeholders.

## **Central Virginia Planning District Commission**

After several months of discussion and consideration, the Local Government Council seeks your approval to change our charter and drop the Region 2000 brand and return to our original organization name, the Central Virginia Planning District Commission. Every organizational name change takes time for people to learn, but over time our government customers and business and non-profit stakeholders will better understand what we do and who they are dealing with by this more accurate reflection of who we are.

A change in our charter requires the approval of localities in the region. A black-lined version and a clean version of the Local Government Council charter is included showing the proposed name changes.

Serving Amherst, Appomattox, Bedford and Campbell Counties; the Towns of Altavista, Amherst, Appomattox, Bedford and Brookneal; and the City of Lynchburg.

# Central Virginia Workforce Development Council and Central Virginia Workforce Development Board

Over the past several months state workforce officials have been working to standardize the state and region's workforce branding and logos. It's always been difficult for a business or a potential worker to know where to go for technical assistance and currently there's a hodge-podge of brands and logos across the Commonwealth that are not consistent and that are locally driven. State workforce officials are now mandating that Workforce Boards and Councils use a common branding and marketing program. Driven by these new requirements, the Region 2000 Workforce Development Council and the Region 2000 Workforce Development Board also ask that the 2015 agreement be amended so that they can drop the Region 2000 brand and use Central Virginia in their name.

A black-lined version and a clean version of the amendments to the 2015 Workforce Area Development Agreement is included showing the proposed name changes.

## Central Virginia Radio Communications Board

The Radio Communication Board started in 1996 as the Central Virginia Radio Communications Board. When the member localities authorized a new bond in 2011 we adopted the Region 2000 name for consistency with the other agencies staffed by the Local Government Council. The Radio Board now asks that we return to the original name, Central Virginia Radio Communications Board.

An amendment to the Region 2000 Emergency Communications Regional Cooperative Agreement is included for your consideration.

## Summary

In all of these documents, our intent is to only change the names of these organizations to make it clearer and more consistent with the mission and purpose of the organizations.

We ask that you share with us any comments that you have on these changes by August 31, 2018 and take action on our request by the end of November 2018. Ben Bowman, our Workforce Development Director and I would be happy to join you for the discussion and to answer questions for Council or staff and to provide our annual report when Council considers these agreement changes.

Thank you for your consideration and the staff and I look forward to continued service to Amherst County, to the greater Amherst community and to the region.

### VI. Old Business

#### A. Landfill Construction

County Administrator Rodgers addressed the Board and said the decision before the Board is to begin construction of the next landfill cell.

Mr. Rodgers explained the option of closing the landfill and constructing a transfer station. Draper Aden Associates provided a report that concluded transfer stations have lower costs and liabilities than operating a landfill.

Ms. Lynn Klappich of Draper Aden Associates addressed the Board and provided a review of the three options which were presented at the June 5, 2018 Board of Supervisors' meeting. Those options were: Option 1 - Continued Operation; Option 2 - Operation by Private Operator; (Note: Option 2 was dropped due to lack of bids received by the County); and Option 3 - Transfer Station.

Ms. Klappich then presented a PowerPoint presentation that outlined four key elements: the loan, use of reserves, VDEQ compliance; and additional operational costs. (See Attachment 1)

Ms. Klappich discussed each of those four key elements:

- 1) Loan was originally for the construction of Cell 2, but could be re-assigned for a transfer station, closure of Cell 1 or area stabilization.
- 2) Reserve Fund could be used for pre and post closure of Cell 1 and to purchase equipment.
- 3) VDEQ Compliance DEQ will continue to inspect closely the landfill due to one notice of violation and three warning letters, which were issued within two years.
- 4) Additional Operational Costs potential increase costs including staff, equipment, fuel, and remediation of groundwater.

M.s Klappich said the Green Ridge Recycling and Disposal Facility in Cumberland County, which County Waste has publically disclosed to DEQ, could be operational in two to three years.

Ms. Klappich said that if the decision is to open Cell 2, this will need to occur soon, at least by February 2019 and certificate to operate by December 2019.

Ms. Klappich advised the Board on Option 3, a transfer operation. She said a transfer station could be completed in 2020, and by 2021, the County would have to initiate closure activities for the landfill. The cost of building a new transfer station would be \$1.6 million.

The Board discussed issues pertaining to the cost of building a transfer station, operating costs, and fuel costs, and issued related to opening Cell 2 and keeping the landfill operational.

Chair Tucker asked Ms. Klappich for a recommendation. Ms. Klappich said she believed it would be an appropriate time for the County to consider a transfer operation.

Chair Tucker made a motion to redirect funding for landfill construction cell closure to transfer station construction.

Supervisor Pugh stated he would like to schedule a public hearing to receive public comment due to the substantial amount of money the County would be investing.

Supervisor Campbell stated he was in favor of building a transfer station.

Supervisor Moore stated she would like to have public feedback.

Chair Tucker withdrew her motion on the floor, and made another motion to direct staff to schedule a public hearing at next meeting.
